- Please provide your current email address— vendor locations will be emailed to participants the week before the event.
- On average 5,000-6,000 people attend the festival throughout the day. The heaviest attendance period is between 5 pm-10 pm. Vendors are encouraged to stay during the entire event.
- The Carbon Valley Music Festival is advertised through newspaper ads, flyers, posters, radio, City Newsletter, and social media.
- Vendor parking is limited to designated areas. Parking next to your booth is prohibited. Your vehicle must be moved after loading/unloading.
- **THE CITY OF DACONO RESERVES THE RIGHT TO REFUSE ANY BOOTHS OR SHUT DOWN ANY BOOTHS THE DAY OF THE EVENT.** The sale of toy guns, fireworks, stink bombs or any projectile items is strictly prohibited. Booth operators offering these items for sale will be asked to leave their booth immediately with no refund given. The Dacono Police Department will be enforcing this with no exceptions.

LIABILITY

Booths are not insured by the City of Dacono. The City of Dacono is not liable for any injuries suffered by individuals or damages to booths or inventory.

BOOTH SPECS

- No tables, chairs or awnings are provided.
- Sandbags, cement buckets or the equivalent ARE required in securing your tents. If you do not provide these safety features, you will NOT be allowed to set up. Wind gusts do occur at Centennial Field.
- Electricity is available and limited. Vendors must provide their own extension cords, and power strips, and pay electrical costs.
- *** BEING AN EXCLUSIVE VENDOR MAY BE CONSIDERED.** For information about being exclusive, please contact Valerie Taylor: 303.833.2317 x123 before completing application. Applicants will be reviewed and approved on a case by case basis. An additional fee of \$60 will be required, if approved.
- All booth vendors **MUST** clean booth areas before leaving. All trash **MUST** be placed in receptacles.
- No one is allowed to walk around Centennial Field passing out information or selling products.
